Bruno Amah, Togo

- Continuing to advocate on behalf of Bruno Amah, a Seventh-day Adventist Church member in Lomé, Togo, serving a life sentence after being falsely accused of murder.
- Amah was sentenced to life in prison in 2014. In the same court ruling, fellow Adventist Church member, Pastor Antonio Monteiro, was acquitted.
